СРАВНИТЕЛЬНЫЕ АСПЕКТЫ ПРОБЛЕМЫ ПРЕДОТВРАЩЕНИЯ МЕДИКО-СОЦИАЛЬНЫХ ПРОБЛЕМ В ВЕЛИКОБРИТАНИИ И РОССИИ

Предметом исследования являются сравнительные аспекты опыта предотвращения медико-социальных проблем, их решения в Великобритании и России в XIX–XXI вв.
