It is considered the formation of the scientific historiography of the Reformation, which became one of the most significant events of the world historical process that influenced the development of Western culture, philosophy, economics and other spheres of society. Attention is focused on a separate story of the Reformation – the history of the formation of antitrinitarian views in the interpretation of the followers of religious reform. It is studied the views of thinkers of the XVII – mid XX centuries, who tried to give a historical justification for the development of socianism.
